ORDER

In pursuance of the **Resolution No. (13)** of the Affiliation Committee, D.U. in its meeting held on 14.05.2013 and under report to the Executive Council, D.U. the Hon'ble Vice-Chancellor, D.U. is pleased to grant provisional permission to the **College of Teacher Education, Dhakuakhana** to start B.Ed. Programme w.e.f. the academic session 2013-2014, subject to fulfillment of the conditions mentioned against it.

Method Subjects – Assamese, English, History, Mathematics, Social Studies, Science.

Compulsory Subjects – Education in Emerging India, Educational Psychology & Statistics, Secondary Education & Teachers and School Organization & Management.

Conditions :

- (1) The laboratories shall have to be separately arranged for the subjects concerned e.g. science and psychology.
- (2) The number of Text and Reference Books along with journals shall be increased in the library.
- (3) The maximum intake shall be **100 (one hundred)**.
- (4) The College shall have to obtain permission from the NCTE for renewal of permission for continuance of the B. Ed. Programme.
- (5) The concurrence of the State Govt. shall have to be procured.
- (6) The College shall have to submit an undertaking to the University to comply with the above-mentioned conditions and relevant University Rules before starting the admission process.
